On motion by C. T. Redd III, seconded by W. F. Adams, and carried unanimously, the Board entered closed meeting pursuant to Section 2.2-3711(A)(1) of the Code of Virginia, 1950, as amended, to interview and discuss prospective candidates for and to consider the appointment of a Third Election District representative on the Board of Supervisors to fill a portion of the vacant term of office, namely the remainder of calendar year 2006, which vacancy was created by the recent death of the Hon. L. E. Byrum, Jr.

Whereupon, F. A. Pleva left the meeting and did not participate in the interviews and discussions of the prospective candidates.

Having completed the closed meeting, the Board reconvened in open meeting, on motion by C. T. Redd III, seconded by W. F. Adams and carried with a unanimous roll call vote. F. A. Pleva returned to the meeting.

In accordance with Section 2.2-3712(D) of the Code of Virginia, 1950, as amended, C. T. Redd III moved that the King William County Board of Supervisors adopt the following resolution certifying that this closed meeting's procedures comply with the requirements of the Virginia Freedom of Information Act. This motion was seconded by W. F. Adams and carried with a unanimous roll call vote.

RESOLUTION

WHEREAS, the King William County Board of Supervisors has convened a closed meeting on this date pursuant to an affirmative recorded vote, and in accordance with the provisions of the Virginia Freedom of Information Act; and,
