RE: APPROVAL OF MEETING AGENDA

On motion by T. G. Smiley, seconded by E. J. Rivara and carried unanimously, the Board adopted the agenda for this meeting as presented by the County Administrator with the following changes: Under Item 6, Consent Agenda, add subitem "g" Adoption of Resolution to Support Legislation to Ban Plastic Bags; and add sub-item "h" Adoption of Resolution to Commend Joanne Smith for Outstanding Service as Executive Director of the Merrimac Center and for a Lifetime of Contributions and Service on Behalf of Troubled Young People.

RE: PUBLIC COMMENT PERIOD – SPEAKERS: ONE OPPORTUNITY OF 3 MINUTES PER INDIVIDUAL OR 5 MINUTES PER GROUP ON NON-PUBLIC HEARING MATTERS

Dan Wright of 354 Horse Landing Road, addressed the Board stating his opinion that Agenda Item 6 Consent Agenda, Sub-item "c" – Adoption of Resolution Authorizing the Issuance of Revenue Anticipation Notes (RANs) for 2008 in Amounts Not to Exceed \$4M and \$6M, should not be placed as a Consent Agenda item. He feels this topic is dealing with tax payers money and the Board should let the public know about this. When placing such an item under the Consent Agenda, it gives the public the idea that something is not right.

Tom Rabino of the Alliance to Save the Mattaponi expressed gratitude to the Board for action taken at its November 13, 2007, meeting regarding its decision to not adopt the resolution authorizing the issuance and sale of water utility bonds by the VRA for the financing or refinancing of the land to be acquired for the King William Reservoir project.

Ann Brummer of 504 Glendale Drive in Richmond, stated that she is a landowner in King William County and just received the new reassessment on this property. She questioned why there has been such an increase in the assessed value of her property.

RESOLUTION TO SUPPORT LEGISLATION TO BAN PLASTIC BAGS

WHEREAS, each year, over 14 million trees and 12 million barrels of oil are consumed for the production of plastic shopping bags; and,

WHEREAS, plastic bag entanglement is the direct cause of death of over 100,000 marine animals; and,

WHEREAS, the environmental impact of these bags is compounded by the fact that they are very difficult to recycle and they contaminate and hinder the recycling of other materials; and,

WHEREAS, these bags create significant litter problems along the roadways, farm fields, and other properties in King William County, and have begun to contaminate the cotton harvested and processed in the County; and,

WHEREAS, the litter and contamination have a negative impact on the aesthetics of the community and the livelihood of those families involved in agribusiness.

- **NOW, THEREFORE, BE IT RESOLVED,** that the Board of Supervisors of King William County, Virginia, hereby requests the General Assembly to adopt legislation that would grant localities throughout the Commonwealth of Virginia the enabling authority to ban or discourage the use of plastic bags.

A RESOLUTION TO COMMEND JOANNE SMITH FOR OUTSTANDING SERVICE AS EXECUTIVE DIRECTOR OF THE MERRIMAC CENTER AND FOR A LIFETIME OF CONTRIBUTIONS AND SERVICE ON BEHALF OF TROUBLED YOUNG PEOPLE

WHEREAS, King William County is a member of the 18 locality Juvenile Detention Commission which owns and operates a 48 bed, secure juvenile detention facility known as "The Merrimac Center"; and,

WHEREAS, Joanne Smith is the Executive Director of the Merrimac Center and was hired even prior to the construction of the building; and,

WHEREAS, she participated in the design development and review; oversaw all aspects of the construction of the facility; developed all operations policies and procedures; developed and implemented a staffing plan to include assuring the superior training of all employees; and,

WHEREAS, she has operated this 48 bed, secure, coed facility since it opened in 1996, and has done so to standards of excellence and without serious incident, protecting the residents and the public, working to assure that time spent by juveniles will be productive and involve increased health, mental health and educational achievements and offer each youth the potential for a better future and productive lives; and,

WHEREAS, during this time and in this facility, Joanne Smith has pioneered initiatives for mental health services; post-dispositional detention; creative learning opportunities such as a greenhouse program, smart boards and residence without television; and,

WHEREAS, she has served King William County well in the capacity of appointee to the Colonial Community Services Board and has served that Board well as Chair; and,

WHEREAS, she has been a leader and a spokesperson on behalf of local governments and troubled youth with the Virginia Departments of Juvenile Justice and Mental Health, Mental Retardation, and with the Virginia General Assembly; and,

WHEREAS, also during this time, Joanne Smith has been a leader in the Commonwealth and in the Nation in juvenile detention and juvenile justice, including serving multiple terms as president of the Virginia Counsel on Juvenile Delinquency; serving as Steering Committee Chair of the Juvenile Female Offenders Network; as

Vice President, Eastern Region, Chair of the Critical Issues Committee, and a board member representing Virginia, of the National Juvenile Detention Association; serving on the Board of Governors of the American Correctional Association where she was also Chair of the Credentials Committee; and on the Virginia Juvenile Officers Association; and,

WHEREAS, Joanne Smith, having led, contributed, and achieved exceptional accomplishments during her 34 years in this profession, will retire from her position on December 31, 2007.

- **NOW, THEREFORE, BE IT RESOLVED,** by the King William County Board of Supervisors this 17th day of December, 2007, that Joanne Smith be commended for her accomplishments, her commitment to the community and her lifetime of service to troubled young people.

RE: VDOT MATTERS - CHARLES E. STUNKLE, RESIDENCY ADMINISTRATOR

VDOT Residency Administrator, Charles E. Stunkle, addressed the Board to provide an update on items from last month's meeting:

- a. Route 610 Mitchell's Mill Road Mr. Stunkle reported that this project is under construction but, currently, there is no time line for completion.
- b. Route 30 between Route 662 (Sharon Road) and Route 658 (Indian Church Road) Request for Sign Indicating "Handicapped Van Entering Highway" Mr. Stunkle advised that he has discussed this request with the Traffic Engineering Department and they are not aware of any type signage of this nature to be utilized.
- c. Work Zone on Route 360 at Pamunkey River Bridge Bridge Scour Project Mr. Stunkle pointed out that the speed limit on Route 360 in the vicinity of the Pamunkey River Bridge has been lowered and posted as a Work Zone due to the upcoming work on the bridge. This Work Zone is in effect now in order to acclimate drivers to the lower speed limit when the actual work begins.
- d. <u>Upcoming Work Session with Board on Proposed Six Year Plan (FY-09-14) for Secondary Roads</u> Mr. Stunkle indicated that he will forward a copy of the draft Six Year Plan for Secondary Roads to the County Administrator and the Board members prior to the Work Session to be held with the Board during its regular January 28, 2008, meeting.
- e. <u>"Welcome to King William County" Sign Location to be Moved</u> C. T. Redd III pointed out to Mr. Stunkle that the "Welcome to King William County" sign positioned on the old section of Route 33 needs to be repositioned to the new section, since the new Mattaponi bridge construction and new road construction is completed.

RE: PLANNING MATTERS - SCOTT LUCCHESI, COMMUNITY DEVELOPMENT DIRECTOR

a. <u>Public Hearing – Proposed Rural Conservation Ordinance</u> - Scott Lucchesi, Director of Community Development, presented and reviewed the proposed Rural Conservation Ordinance, indicating that this text amendment will create a new zoning district, that of the RC (Rural Conservation) District. He indicated the purpose of this district is to provide for low-density single-family and age restricted residential development within the rural areas of the County, by allowing one residential building lot per five acres of land for single family homes, and one residential building lot per four acres of land for age restricted homes. Continuing, he explained that in order to protect the rural character, homes may be clustered

together within a development in a manner that will protect the view shed and provide open space. Further, Mr. Lucchesi stated that the RC District classification consists of both residential and open space components in which agriculture is a permitted use. The regulations are intended to provide assurances that open space will be preserved and maintained by requiring a minimum of 70% of the development being placed in a conservation easement. The District will provide sufficient design flexibility to provide an incentive to develop cluster residential development with open space.

Thereupon, the public hearing was declared open by the Chairman and the following persons appeared to speak:

John Breeden questioned how many lots and subdivisions will this District be allowing in the County. He stated his opinion that instead of adopting amendments or ordinances piecemeal style, that the overall Comprehensive Plan should be adopted as a whole.

Billy Mills, a resident of King and Queen County, and a realtor doing business in King William County, addressed the Board in favor of approval of this proposed Ordinance. He cited several benefits this will bring to the County.

Pete Glubiak, an attorney practicing in King William County, also spoke in favor of adopting this Ordinance. He indicated that this would be a tool to be used by the Planning Commission and the Board of Supervisors to better plan for growth, and also to help preserve open space.

There being no other persons appearing to address the Board, the public hearing was declared closed by the Chairman.

b. <u>Adoption of Proposed Rural Conservation Ordinance</u> - On motion by E. J. Rivara, seconded by T. G. Smiley and carried unanimously, the Board adopted the Rural Conservation Ordinance as presented

<u>RE: COUNTY-OWNED PROPERTY MATTERS – FRANK A. PLEVA, COUNTY ADMINISTRATOR</u>

a. Public Hearing – Conveyance of Real Property to Mt. Olive Residents - Frank A. Pleva, County Administrator, stated that this is a public hearing to receive comments and to consider the proposed conveyance of county-owned real properties, described as Lots 1-7 in the W. H. Gray Manor subdivision, to various low and moderate income household beneficiaries of the Mt. Olive Community Development Project. The lots are part of parent Parcel 104 on King William County Tax Map 44. The Subdivision and the subject lots are located on the north side of State Route 632 in the Mt. Olive community.

Further, Mr. Pleva explained that the County acquired and subdivided the property to provide suitable building lots for housing, meeting minimum federal housing standards, for those low and moderate income households within the Mt. Olive Community Development Project area that could not obtain clear title to the properties upon which they currently reside. The inability to obtain such clear titles, as stipulated by federal Community Development Block Grant (CDBG) requirements, prevents the use of CDBG funds for the improvement of the substandard housing conditions on these title questionable properties. Federal funds will finance the proposed construction of the low and moderate income housing on the subject lots.

Thereupon, the public hearing was declared open by the Chairman for comments.

No persons appeared to speak, therefore, the public hearing was declared closed.

b. Approval of Conveyance of Real Property to Mt. Olive Community

Residents - On motion by W. F. Adams, seconded by O. O. Williams and carried unanimously, the Board approved the conveyance of Lots 1-7 in the W. H. Gray Manor Subdivision to various low and moderate income household beneficiaries of the Mt. Olive Community Development Project. These lots are part of parent Parcel 104 on King William County Tax Map 44, and are located on the north side of State Route 632 in the Mt. Olive community.
