Agenda Item 8. New Business

Ms. Sherry Graham gave a brief description of the VDoT Smart Scale project that includes the submittal of a 10 foot wide bike & pedestrian path from Kelley Lane to Pinecrest. This also proposes crosswalks at the intersection and will go before the Transportation Board in June.

Chairman, Wagner was curious if this was in connection with other current VDoT projects.

Mr. Ron Etter gave an update on Sweet Sue Solar, stating that they had reached out for building information and they are working on Permit by Rule, which should be done less than a year from now.

Mr. Etter also discussed the drainage issues at Aylett Mini Storage.

Chairman, Wagner expressed his concerns of where the drainage goes to.

Mr. Greenwood was curious as to whether they would plant landscape buffers.

Mr. Ron Etter let the members know that the SmartScale Park and Ride was also about to kick-off.

Chairman, Wagner was curious how many cars would be allotted in the area.

Mr. Etter told Commission that he never sees more than 7-8 cars so he did not think that reducing the lots to 22 will exceed the volume.

Mr. Ron Etter also told members that King William Manor is coming along, Hamilton Holmes Solar is almost ready to go online, and the Burger King lot is a staging lot for VDoT for part of the utility relocation of water lines.

Mr. Etter also pointed out that he had only received two written comments in regards to input on the ordinance.

Ms. Janie Rhoads was curious as to what the concerns were on Family Division.

Mr. Ron Etter let the Commission know that the public would like smaller lots for family division.

Agenda Item 9. Staff and Special Committee Reports

Mr. John Breeden gave a brief synopsis on the Solar Subcommittee, stating that they added a few things to the ordinance that were sent to the PC on July 21, 2020. Mr. Breeden felt that the solar ordinance was already good, that it just needed some fine tuning, but he was very pleased with how smoothly everything went.

Chairman, Wagner stated that the Solar Subcommittee did very well and the group was very knowledgeable. He was wondering if there were any current applications in for solar and also what the timeline would be to finish the ordinances.

Ms. Janie Rhoads was curious how the timeline would unfold and what it would look like.

Mr. John Breeden extended a thank you to staff and stated that he was excited for the ordinance and the comp plan.

Chairman, Wagner stated that it was a good meeting and thanked staff.
