ORDER

THIS DAY came the Board of Supervisors of King William County, Virginia (the "**Board**"), by counsel, and petitioned this Court to order a special election for the office of Clerk of King William County Circuit Court, King William, Virginia.

IT APPEARING TO THE COURT that the elected Clerk of King William County Circuit Court, King William, Virginia, has announced her resignation, effective February 1, 2022; and that a vacancy will occur in the office of the King William County Circuit Court, Virginia effective February 1, 2022; that the Board of Supervisors of King William County, Virginia, has petitioned the Court pursuant to Va. Code § 24.2-228.1 to enter an order requiring County election officials to conduct a special election to fill such vacancy on November 8, 2022; that the Board unanimously adopted a Motion on January 24, 2022 in support of said petition; that the Board properly asks that the special election should be held occurring on November 8, 2022, pursuant to Va. Code § 24.2-226.

UPON CONSIDERATION THEREOF, it is hereby **ORDERED** and **DECREED** that the Petition be **GRANTED** and a special election to fill the office of Clerk of King William County Circuit Court, King William, Virginia **SHALL** be held at a special election on November

8, 2022, pursuant to the provisions of Virginia Code §§ 24.2-226, 24.2-228.1, 24.2-681 and 24.2-682.


The Clerk of this Court is directed to send a certified copy of this Order forthwith to the State Board of Elections, pursuant to Va. Code § 24.2-684, and to counsel for the Board of Supervisors of King William County below.
